















### Where did we come from?



- The concept of Community Foundations started in America – Ohio 1914
- 'Derbyshire Community Foundation' as we used to be called, was set up in 1996 since then we have distributed c.£17million to over 8,700 Derbyshire groups
- There are 47 Community Foundations in the UK collectively we are the UK's 4<sup>th</sup> largest Funder having distributed over £1bill in grants

#### What do we do?



Aim to Improve the quality of community life in Derbyshire & tackle disadvantage

By providing grants to community & voluntary sector groups striving to make a difference in their area.

# Where does the money for grants come from?



- We find people and businesses who care about Derbyshire and share our aims in improving Community life
- We pool their donations to create an endowment fund
- Grants are made from the interest generated on this Fund

### Reaching the parts other funders don't!



There are an estimated 3,700 voluntary and community organisations operating across Derbyshire,

Nationally, c. 50% of organisations are micro in size (annual income under £10,000) but they receive only c. 1% of national voluntary sector income and it is therefore at this grassroots level, where the Foundation's grantmaking can and does make a real difference across Derbyshire

### Most grants...

- 1) We are a small funder so most grants up to £2,500
- 2) Capital (equipment), running costs (core)& one off events / projects
- 3) Must be a constituted group with bank account, management committee
- 4) Have a year to spend if successful

## FD General Fund



- Supports a broad range of small community and voluntary groups with a variety of different costs
- Maximum grant of £2,500
- Total project cost should not exceed £5,000

### Hall Family Fund



- To support projects tackling rural issues, or working in rurally isolated areas.
- Maximum grant of £2,500 available
- Can be for capital, revenue or one off projects or events
- Donors visit up to 50% of awarded projects

## Freemasons of Derbyshire Fund



- Established by the Freemasons of Derbyshire Provincial Grand Charity to support community life and tackle disadvantage across the County
- Main priority is to promote the advancement of health and well being and support the most vulnerable in our communities
- Maximum grant of £2,500 for capital projects
- Volunteer panel visit 25% of awarded projects

# The Walbrook Fund



- To support community activity that directly helps those facing disadvantage
- Can be for capital, revenue or one off projects or events
- Grants up to £2,500 available

### Derbyshire Volunteer Fund



- Grants cover all Derby City and Derbyshire
- Grants up to £2,500 available
- Grants supporting the recruitment, retention and training of volunteers.
- Volunteer expenses, courses, conferences, advertising, DBS checks, equipment to support their roles

### William & Griselda Kerr Fund



- Grants cover all Derby City and Derbyshire
- Grants up to £2,500 available
- Any project that uses the arts, such as music, dance and drama, to work with and help some of the most vulnerable in society.
- Any project that uses horticulture to develop skills, health and opportunities such as gardening, allotments, farming.



#### Jefford Weller Fund

- Covers the whole of the County
- Grants up to £2,500 available
- Any project supporting those at risk of homelessness (targeting preventative action) and direct support to those currently homeless
- We also have the Fothergill Fund and the Churchhouse Fund with a similar ethos

### Myth busting



- We fund groups of any size big or small
- Although a quarter of all groups have an annual income below £10,000
- You don't have to be a registered charity
- Yes we fund core costs day to day running
- All bids are treated equally, the assessment process is transparent and fair (it doesn't matter who you know!)
- It is worth applying 80% of groups are funded

### **How to Apply**



- Always contact the Foundation first
- Chat to us about your project to see if there is a suitable fund
- Have an idea of budget and timeframes
- There are no fixed closing dates but we would advise submitting your application three months before the project takes place
